Rule 2 (b)

Associate Corporate Membership

"Any firm, company, society, or other organisation outside the United Kingdom and the Republic of Ireland, whether or not engaged in bookselling; together with all firms, companies, societies and other organisations in the United Kingdom and the Republic of Ireland which, in the opinion of the Board, are not involved in bookselling".

"Associate Corporate members shall be entitled to such benefits, services and publications (whether free of charge or not) as the Board may from time to time decide. They shall be entitled to attend and speak at general meetings, although not Branch or Advisory Group meetings, but may not vote".

Rule 3

"Applications for associate corporate membership shall be made through the Executive to the Board".

Rule 5

"Each associate corporate member shall pay on 1st January each year such subscription as the Board shall decide".
